

Terms and Conditions

Your use of the SonShine website (the “**Site**”) and your application to the Global Connection Competition (the “**Application**”, and the “**Competition**”, respectively) offered on this Site are governed by the terms and conditions set forth below and all other disclaimers, guidelines, policies and terms and conditions appearing on the Site (collectively, the “**Terms and Conditions**”). Aim of the Competition

The aim of the Competition is to strengthen the connection between Jews around the world and Israel.

Eligibility

The Application process is open to all applicants who are at least 18 years of age. All Applicants must represent, and hereby represent, that any ideas and/or initiatives submitted to us during the Application process and Competition are their own, original ideas and/or initiatives, and all rights to such ideas and/or initiatives belong to them alone, and not to any third party. If you are employed or affiliated with a specific third party, you may be asked in a further point in the Application process to obtain the consent of such entity to your participation in the Competition. These requirements apply equally to anyone who will assist you in developing ideas and/or initiatives for the Application.

We may reject any Application in our sole discretion, without providing explanations.

The Process

In order to be eligible for the Competition, an applicant must submit the Application through the Site during the period from February 7, 2019 to March 31, 2019. All Applications will be reviewed. Selected applicants (who have passed the initial review process) (“**Finalists**”) will be invited to present their ideas and/or initiatives (the “**Finals**”), following which, one winning Application will be chosen (the “**Winning Application**”). The identity of the Applicant who submitted the Winning Application (the “**Winning Applicant**”) will be announced no later than the end of December 31, 2019.

Award

The award of the Competition (the “**Award**”) is intended to recognize innovativeness and significant achievement. For more information regarding the criteria of a strong proposal, see <http://gcc.sonshine.org.il/whats-a-great-idea/>.

The Award is a cash award equal to USD \$10,000.

We will have sole discretion to make all decisions with regard to the grant of the Award, including determining the date of the announcement of a winner and the delivery of the \$10,000 prize to the winner and any other details regarding the Award. The Winning Applicant will not have any rights or claims in this regard.

In the event that a Winning Application is disqualified or is not able to meet our requirements, we may replace it with another applicant, or may elect not to give away the Award, in each case in our sole discretion. Eligibility for the Award is personal and is not assignable or transferrable.

Intellectual Property

Any and all information provided to us is deemed non-confidential and no confidential relationship of any kind is hereby established. We are not obligated to keep secret any information that you submit under the Application process, nor under any other means by which you contact us. Any information or materials you submit to us may be retained by us and we have the unrestricted right to use and disclose any submitted ideas and/or initiatives. Any disclosure by you does not obligate us to adopt your idea and/or initiative. Use of personal information is subject to the Privacy Policy.

We will be granted, and are hereby granted, by all Applicants, an exclusive license to review, develop, commercialize and exploit the ideas and/or initiatives submitted to us during the Application process and Competition, including “No-Shop” rights up until the announcement of the Winning Application, and 6 months thereafter.

Additionally, if you are the Winning Applicant, you hereby assign to us all right, title and interest in the ideas and/or initiatives submitted to us during the Application process and Competition and all matter disclosed in your Application (other than the personal information set forth therein) (collectively, "Submission"). In addition, to the extent the assignment above is not effective or enforceable, you hereby grant us an exclusive license to review, develop, commercialize and exploit the Submission and ideas and/or initiatives submitted to us during the Application process and Competition. Following the announcement of the Winning Application, if you are the Winning Applicant, you hereby grant us an exclusive, irrevocable, freely sublicensable and assignable, worldwide, royalty-free license to develop, use, modify in any manner, commercialize, implement and exploit the Winning Application for any and all purposes, without obligation to you of any kind other than payment of the Award.
